

# UNDERSTANDING YOUR QUAIL CREEK BILLS

## **Member Account**

To be authorized to charge to your Member Account, you will need to sign a Signing Privileges form. When you use your member account to charge at the Pro Shop, Member Services, The Grill restaurant, etc. you will receive a monthly statement with your charges. Statements arrive either by mail or by email. You can update your statement delivery method online under your Member Center profile or with Member Services 520-393-5822.

All authorized members in the home can independently charge using their member IDs (key fob, wristband, or member card). These charges are combined into one monthly statement.

A benefit of charging to your member account is the Loyalty Reward Program at The Grill! Every dollar spent at The Grill for food or alcohol will earn you Loyalty Points. Once you have accrued 250 Loyalty Points (equal to \$250), you will receive a \$25 electronic credit as a Loyalty Gift to your member account. Points are accrued independently and you can view your current points and gifts on the website under your Member Center profile.

Statements are sent the first week of the following month and payment is due by the 25th of the month (for example, your January statement is received the first week of February and payment is due February 25th). It is important to make a prompt payment to ensure your access to the community amenities is not revoked.

The recommended payment method is to visit quailcreekhoa.org to use a credit card or checking account.

If you prefer to send a check in the mail or through your bank's bill pay, please understand it takes about 2 weeks for the check to arrive at our Lockbox and for it to be applied to your account. **Be sure to include your 8 digit member number** in the memo line of the check, to ensure your payment is applied to your specific Member Account. # **Property Account**

POA stands for "Property Owner's Association". It is very similar to HOA which is "Homeowner's Association".

POA Dues are assessed to your Property Account bi-annually. The first half dues are assessed in early January and are due by February 1st. The second half dues are assessed in early July and are due by August 1st. Statements arrive either by mail or by email. You can update your statement delivery method with Member Services 520-393-5822 or by emailing HOADUES@Robson.com.

You may see the breakdown of the POA Dues on your statement. The three categories explained are below:

- Amenity Fee (use of the community facilities)
- Operating (maintenance & operations of the community)
- Reserve (future community purchases)

The POA Dues amount will cover up to two residents per home. If there are more than two residents in your home, you may see "Associate Member" dues included on your bill which covers the additional member(s) residing with you.

If payment is not received by the due date for each half, your Property Account will be deemed delinquent and a 10% late fee will be applied. Quail Creek CC POA has the right to suspend the privileges of any delinquent member. Suspension would prevent you from reserving Event tickets or tee times, charging to your Member Account, checking into the Quail Creek facilities, etc.

If you would like to pay for the entire year, you will need to mail a check to the address listed below.

The recommended payment method is to visit quailcreekhoa.org to use a credit card or checking account.

If you prefer to send a check in the mail or through your bank's bill pay, please understand it takes about 2 weeks for the check to arrive at our Lockbox and for it to be applied to your account. **Be sure to include your 10 digit property number** in the memo line of the check to ensure your payment is applied to your specific property account.
